It's simple to receive your Invest In America discounts. Just follow the steps below and you're on your way to receiving great discounts from General Motors and Chrysler.

Note: Members, dealerships and staff may visit and complete the discount certificates online at any computer, at any time. The authorization discount coupon codes are provided on the participating manufacturer's website or dealership. **The Erie FCU does NOT supply the discount authorization coupon codes.**

Step 1: Visit the Invest In America Website

Next Steps

- 1. Keep your authorization number:** You will need your authorization number to redeem your vehicle discount. Please print this page or write down the authorization number for the dealer.
- 2. Visit your dealer:** When you are ready to make your vehicle purchase, present the authorization number and proof of program eligibility to your salesperson.
- 3. Confirm your discount:** After you select your new vehicle, the dealer will review a Customer-Dealer Agreement with you. Confirm that supplier pricing has been applied to the invoice and sign the Customer-Dealer Agreement.
- 4. Drive home in your new GM vehicle!**

Once these steps have been completed, the user will receive an authorization number that can be used for the dealer discount. The user will also receive an e-mail displayed below to the e-mail address supplied during registration.

Requirements for the Credit Union Member Cash Program from Chrysler

Eligible Member:

An "eligible Participating Credit Union Member" is a member of a Participating Credit Union, who purchases or leases an eligible Chrysler vehicle through a franchised Chrysler, Jeep or Dodge dealer and finances this vehicle through such Participating Credit Union. Dealer must verify in the Incentive Program Terms & Conditions posted on DealerConnect that the credit union involved is a Participating Credit Union, and must retain all records relating to a vehicle sale or lease under the Incentive Program.

Participating Dealer:

All franchised CHRYSLER Corporation LLC Chrysler, Jeep, or Dodge dealers who agree to abide by these Terms & Conditions are eligible to participate.

Program Compatibility:

This Incentive Program is not compatible with the following programs:

- APR Financing programs
- This program is compatible with all other programs.
